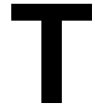

## **NOTES ON THE CONFERENCE/COUNCIL TREASURER'S REPORTS**

The line numbers listed on the Treasurer's Reports are referenced to the numbers used by Canada Revenue Agency in Form T3010E(13) "Registered Charity Information Return"- Schedule D.

### **Registered charity information return reporting requirements :**

If your conference's annual revenue is less than \$100,000 and the amount of all assets not used in charitable programs is less than \$25,000(Line 4250) ***you will be required*** to report the financial activity in Section D of the return instead of Schedule 6 of the registered charity information return. If your conference does not qualify to use form D, you will be required to complete the long form on Schedule 6

Based on the financial information reported in 2016 all of the conferences in Toronto Central Council should use Section D

### **Gifts in Kind**

If you have issued tax receipts for gifts in kind, the total amount of the receipts should be reported on line AA in the revenue section  
The same amount should be recorded as an expenditure as part of line 4920 - other expenditures

## **Additional reporting lines in Section D of the return**

### **Line 5000 How much did the charity spend on Charitable Programs?**

Total the expenditure lines marked with \*\*\* plus any travel costs directly related to home visits and enter that amount into the line 5000 in section D

### **Line 5010 How much did the charity spend on management and Administration?**

Line 4950 less the amount recorded in line 5000
